2016 HIGHLIGHTS



PROTECT CHILDREN FROM TRAFFICKING

NC Child played a key role in the lobbying effort to pass important legislation to protect children from child trafficking.



INCREASE ACCESS TO EARLY EDUCATION

With our partners, NC Child helped convince lawmakers to make NC Pre-K and child care subsidies available to over 500 additional children.



PROTECT FOOD ASSISTANCE

When legislation was introduced to cut eligibility for food assistance for thousands of low-income families and their children, NC Child worked with our allies to keep that provision from becoming law.



PREVENT INFANT MORTALITY

NC Child staff worked with policymakers and health experts to create a statewide plan to reduce North Carolina's persistently high infant mortality rate with a specific focus on eliminating racial and ethnic disparities.



CREATE PATHWAYS TO LITERACY

In partnership with the Pathways to Grade-Level Reading Initiative, NC Child helped create the Measures of Success – whole child indicators to help us understand how children are faring on their path to third grade reading – which were adopted by the state with the support of the legislature.



PROTECT INVESTMENTS IN CHILDREN

NC Child mobilized local constituencies and worked with state partners to stop the so-called "Taxpayer Bill of Rights" (TABOR), a proposed constitutional amendment that would have permanently restricted the ability of state leaders to fund key investments in children's health, safety, and education.






2016 FINANCES
